Monroe Drive Update



Monroe Drive/Boulevard Complete Street Project

The MLPA Traffic Committee continues to focus on the Monroe Complete Street planning, a project to revamp Monroe/Boulevard to improve safety and efficiency. We are studying 13 concepts that seek to lessen the anticipated cut through traffic once the Monroe plan is implemented. The Complete Street plan is still being studied and designed by the City and Renew Atlanta.

The next step in the process will take place on **Tuesday, February 28, 6:00 PM at Ebenezer Baptist Church**, 101 Jackson Street, 30312. The Renew Atlanta team should have several alternative designs to present. Those attending will have an opportunity to hear a discussion of each and to provide input on their preferred design.

Mark your calendars now. Plan to attend and bring your neighbors. This is our best opportunity to have input on the future of this vital artery through our neighborhood.

Security Patrol Adds Shifts in Response to Recent Crimes

As often happens during the holidays, there was a spike in petty crime in the neighborhood. You've probably noticed chatter on Nextdoor about cars being rifled through, mailboxes opened, and packages lifted from porches.

In response, the MLPA arranged additional shifts by the Morningside Security Patrol(MSP) to try and catch this latest round of crooks. As Officer Ric Vasquez, the head of the MSP, has said, "These types of petty criminals are often the hardest to catch. They drive around the neighborhood, often striking at different times so it's difficult to schedule officers

to catch them."

Despite the difficulty involved, MLPA has added some overnight patrols in hopes that the extra patrols will either catch thieves in the act or at least deter them. We urge you to join MLPA as Security Plus members so we can continue to fund this vital function. In addition, we are organizing a Neighborhood Watch Security Committee that will meet regularly, taking concrete steps to make our neighborhood less attractive to criminals.

There are several steps you can take now to help out:

1. Meet your neighbors and get to know them. As we have reported before, criminals avoid neighborhoods where the people know and look out for one another. Talk to your neighbors so you'll know what's to be expected that way you'll

know and can report it when something unexpected occurs. Our best defense against crime is diligent neighbors.

2. Attend the Security Forum on **February 6th at 7:00 PM at Haygood United Methodist** and encourage your neighbors to join you there. We will meet with the new Zone 2 command leadership (see related article), discuss ways we can all stay safe, and hear how we can make our neighborhood a place criminals avoid. Check the <u>mlpa.org</u> website for updates including location.

3. When incidents occur, call 911 and request that a report of your incident be filed. You may not be aware, but depending upon the severity of the crime, reports may not be filed if no request is made. That is why you'll often see reports on Nextdoor that never show up on the Morningside Security Report.


4. Request improved lighting for your street. If there are wooden utility poles that either have dim or burned out lighting, call Georgia Power at **1-888-891-0938** for replacement. If the utility pole is metal, the lighting is the responsibility of the city-call 311 to report outages or go to <u>atl311.com</u> to report it.

5. Join the Security Committee. Go to mlpa.org to volunteer.

6. Get involved with Court Watch and legislative reform initiatives. It is estimated that approximately 75% of the petty crimes (car break-ins, mail theft) are the acts of teenagers, as they commit crimes without fear of punishment due to the lax point system currently in place. There are efforts to reform this to provide punishment to those committing the crimes. Again, express interest in these issues by going to <u>mlpa.org</u> to volunteer.

7. At the risk of sounding like a broken record, remember to lock up and store valuables out of sight. Many of the crimes we have experienced were crimes of opportunity.

Zoning Committee Update & Report on Rock Springs Presbyterian Property Rezoning

Hedgewood Properties met with the MLPA Zoning Committee on Tuesday, Jan. 3rd to present their rezoning case, Z-16-080, 2059 Manchester Street, which was deferred from December. The developer had acquired another industrial property adjacent to their Manchester Street development on the corner of Manchester and Liddell. They presented plans for adding 9 new units to the existing townhome community. The committee requested some modifications to the plan to eliminate the use of a curb cut as these often result in cars obstructing the sidewalk. We also requested that the developer obtain letters from the existing townhome owners whose property was adjacent to the proposed units. These conditions were included in the motion to approve which passed.


While at our meeting, the developer also updated us on progress for the Rock Springs Presbyterian property. In December we reported that Rock Springs Presbyterian entered into an agreement with Hedgewood Properties to develop a townhome community on their land in exchange for much needed funding to maintain this historic building.



Both the architect and developer answered many questions and issues raised by the neighbors and committee members in attendance. The presentation to MLPA Zoning was informational only so no vote was taken. Since the property is in the Piedmont Heights neighborhood, the next step is meeting with their zoning committee and board where votes will be taken. MLPA will continue to monitor progress and inform neighbors of opportunities to engage on this important rezoning.

The other variances the committee considered were V-16-326, 1620 West Sussex Rd., and V-16-345, 1653 North Rock Springs. V-16-326, 1620 West Sussex Rd. was to add a "sports court". The motion was to approve with the condition that no exterior overhead lighting be installed to light the court. V-16-345, 1653 Rock Springs Rd. sought to remove the existing addition and add back an addition to the rear of the house. It was also approved.

In Friday's New York Times, columnist David Brooks talked about common mistakes buyers make in choosing a home. As he said, "Choosing this or that house has only a moderate effect on joyfulness. The neighborhood you choose, and the social fabric you enter, is more important than the structure you adore." The MLPA has been working on several initiatives designed to benefit the neighborhood in tangible ways:

- Security. We are working with the Morningside Security Patrol, the Neighborhood Watch Committee, and several volunteers to identify ways to ensure that our neighborhood remains the livable, walkable, family-friendly in-town neighborhood it is known for being.
- Sidney Marcus Park. We are forming a friends group for Sidney Marcus Park with the goal of revitalizing one of our most popular and family-friendly parks.

Trees Atlanta in Morningside



Trees Atlanta has two projects slated for Morningside in January. It begins with a reforestation project in Morningside Nature Preserve on Saturday, January 14 at 9:00 AM. This is followed by a street planting along Courtenay in Morningside slated for Saturday, January 28 at 9:00 AM.

Trees Atlanta is asking that neighbors help out by volunteering for either or both. Here's more details:

On Saturday, **January 14th** Trees Atlanta will work at Morningside Nature Preserve! There will be plenty of opportunities for all ages, but note that children must be accompanied by an adult. Not only will you be helping our urban forests, but you'll also learn about controlling invasive species and the correct way to plant new trees.

Here's the details from Trees Atlanta:
What: Forest Restoration Planting & Chinese Privet Removal
When: January 14, 2017 9am - 12pm
Where:1944 Wellbourne Dr. NE, Atlanta, GA 30324 (Morningside Nature Preserve | Park along street near Morningside Trailhead)
Who: Volunteers of All Ages

The second opportunity to help out comes on **Saturday**, **January 28 at 9:00 AM - 12 PM** when there will be a tree planting along Courtenay Drive in Morningside. There are more details <u>here</u>.

Some guidelines for helping out include:

- It is important to arrive on time so each volunteer sees our demonstration (it takes 10 minutes). We also want all volunteers to stay for the entire project.
- Dress in warm layers, closed-toed shoes or boots (waterproof is best), and clothes that can get dirty.
- Bring drinking water in a reusable container. No one-time-use plastic bottles, please. It is important to stay hydrated even in the cold.
- Forest Restoration is hard work, so eat a good breakfast and come prepared to work hard.
- Projects happen rain or shine, so please check the weather beforehand and come prepared.
- Trees Atlanta will provide all necessary tools and instruction, though volunteers may prefer to bring their own work gloves.

School News by Matt Westmoreland

Please join Superintendent Carstarphen and Board Members at Inman Middle on **February 8 at 6pm** for a Grady Cluster community meeting and an update on short-term and long-term solutions to capacity challenges.

Over the next five years, the Cluster will see a \$20 million renovation of Morningside Elementary, a \$33 million renovation and addition at Grady High, a \$52 million renovation and addition at Howard to become the cluster's new middle school, and an \$8 million investment for additional field space.

You can find other APS updates in my Winter Newsletter.

Some highlights:

- The district recently received a \$1m grant to fund literacy training for 1,500 elementary teachers.
- Last fall, the district launched a Request for Information, which asked applicants to present ideas around early learning and literacy, alternative school programming, wraparound services, school turnaround, and talent development. The administration will present any recommended partners at the February Board meeting for action in March.
- Last month, the Board established a task force to examine surplus APS properties and to what extent they could be

used to grow the supply of affordable housing in Atlanta. The commission will meet monthly and present recommendations in June. The Board also adopted a policy outlining preliminary affordability goals for projects involving APS buildings that receive public funding.
