Call to Order and Welcome.

Ben Nemo called the meeting to order.

Minutes.

A motion to approve March 2019 meeting minutes was unanimously approved. A motion to approve revised December 2018 and January 2019 and February 2019 minutes was unanimously approved

 - Sunken Garden and Lenox Wildwood Park friends groups have held kickoff meetings
 - Met with Matt Westmoreland to learn how to better work with Park Pride and Atlanta Parks & Recreation
 - Friends of Park Groups
 - 160 people committed 450-500 hours to remove invasive species from neighborhood parks and recreation areas in the first quarter

Reports from Public Officials.

Jennifer Ide updated the board on TSPLOST Renew/Atlanta. 10th St. & Monroe intersection will be separated from Monroe complete streets and receive separate funding.

ADA compliant tennis courts and pathways in Lenox-Wildwood Park will be constructed soon. Lenox Road and Johnson Road made the list for resurfacing.

The board made a motion to alternate between private meetings and more public themed meetings (Security, Parks, Master Plan) that would attract more neighbors.

Financial Statements.

The March bank balance was \$52,333.08. A motion to approve February financials was unanimously approved.
