Sidewalk Survey

The Master Plan Initiative Committee has undertaken a project to make the neighborhood safer for bikes and pedestrians. As a first step, we opened a survey to determine how extensive the problem of broken sidewalks within the neighborhood might be. Thanks to everyone who participated in the survey. We had over 200 responses! The results of the survey are summarized below.

Does your sidewalk need repair?

Yes 22% No 54%. N/A 24%

If yes, how extensive is repair?

Partial (<50%) 62% Extensive (51-75%) 16% Full 22%

 If repair necessary, are there special conditions (tree roots, etc.) that would make repair more expensive?

Yes 43% No 57%

Would you be willing to pay up to \$2250 to repair?

Yes 38% No 62%

• If MLPA could work with the city to adopt a sidewalk renewal program to reduce hassle and cost would you be willing to pay to repair your sidewalk?

Yes 75% No 25%

Most neighbors said that they are aware of other broken sidewalks nearby with 87% in front of a house and 13% in front of a business.

Many neighbors also stated an interest in having a sidewalk if they or their street did not already have one. Concern was voiced especially for streets where traffic is heavy and children are walking to school. Requests were made for ramps at the end of blocks for bikes, strollers, wheelchairs and all who use the sidewalks.

Some neighbors reported that shrub overgrowth encroached onto sidewalks narrowing the useable path. Finally, curb repair and replacement of missing curbs was mentioned to ease parking and crossing.

The current Atlanta sidewalk policy makes individual property owners responsible for repairing sidewalks. This policy is viewed by most as unfair and nearly impossible to enforce. Some city council members are in support of requiring Atlanta to pay for sidewalk repairs just as potholes are repaired with tax dollars. At this point, however, there is little money allocated to sidewalk repair.

It may be that a class action lawsuit that seeks to compel Atlanta to comply with the Americans with Disabilities Act will force change. Requiring Atlanta to comply with ADA requirements for the installation of curb ramps, sidewalk repair and safe pedestrian access in construction zones will benefit everyone. Still settlement of any lawsuit may be years off. So, what now?

First of all, the Master Plan Initiative Committee will continue to work with city officials and use supporting data such as the survey results to seek ways to improve the sidewalk repair process for our neighborhood.

In the meantime, you may report a city sidewalk hazard to ATL311.com, the online reporting system. (You may also dial 311 to report a hazard.) Once you complete the online form, a service request will be created. The city will then inspect the sidewalk, determine if repair is warranted and, if so, assign a service date for the Department of Public Works to complete the repair at their cost. Amazingly enough, we have had neighbors report success with process!

The second way for sidewalk repair is for the homeowner or business to handle it on their own. In this case the individual or business determines the desired contractor and fills out and submits an online <u>permit application</u>. The city then reviews the permit application and presumably approves. Then the homeowner or business hires the contractor to make repairs and pay the contractor directly.

Thank you again to all who took the time to respond to this survey. We will continue to search for ways to simplify sidewalk repair and also lobby for new sidewalks in our

Security

Updates from Atlanta Police Department (APD) - Zone Commander Retirements Announced

Effective December 11, Major Rick Vazquez will retire as Commander of Zone 6. Vazquez has worked in Morningside for more than 20 years. He knows our neighborhood very well and will continue to manage the MLPA Security Patrol. Vazquez has played a pivotal role in planning and executing patrol and traffic plans for several large-scale national events such as the SEC Football Championship game

and Chick-fil-A game. He is also known for his work in homicide. The replacement Zone 6 Commander has not yet been named. In the interim, the MLPA will be working directly with Captain Clay in Zone 6.

Effective November 14, Major Barry Shaw retired as Commander of Zone 2. Shaw has been a great support to Morningside. He was known for pulling officers off traffic duty to patrol "hot spots" and was particularly effective in our neighborhood with regularly clearing urban camp sites in the Morningside Nature Preserve. His replacement is Major Andrew Senzer.

Major Senzer began his career 24 years ago, patrolling the streets of Zone 6 in East Atlanta. It was during his time assigned as the beat officer for the Kirkwood neighborhood that he developed a passion for community policing and took pride in the relationships that he developed with the residents and business owners on his beat. We look forward to working with the Major.

Morningside is monitored by two police zones. APD Beats 212 in Zone 2 and 613 in Zone 6 handle all crimes in our neighborhood, which according to the city, includes our immediate area plus the town house neighborhoods and businesses on the north side of Cheshire Bridge.

Piedmont and Cheshire Bridge form part of the border for Beats 212 and 613. Crimes along these streets will be handled by the officer on patrol who closest to the incident, regardless of zone. Zone 6 covers most of Morningside and currently has 2 cars patrolling the neighborhood.
