#### **President's Note**

If you are as surprised as I am that it is October 15, just imagine how you'll feel when I say the same thing in my intro in November. These three topics however will make you want to stand up for the neighborhood until then.

1. City Council President candidates represented! As part of our commitment to educate our neighborhood better on local elections, we were fortunate that three CCP candidates – Council Member Natalyn Archibong, Mike Russell and Doug Shipman – joined us Monday night to introduce themselves and answer questions on key neighborhood topics such as crime, variances and permitting, alcohol licenses, the tree ordinance, and even vaccine requirements. We had 50+ neighbors attend that all learned a great deal about what sets each candidate apart and I for one was impressed with the new ideas and passion each one had. I highly recommend viewing the first ~40 minutes of our recorded board meeting here if you'd like to benefit from this same experience and learn which candidate may best represent you. Another takeaway for me was that it is important to think about that role as a partner to the mayor – and whether you think

the candidates for each office that you vote for can work well together. While we're on the topic of City elections, did you attend the virtual District 6 Candidate Discussion that we hosted with our friends in Piedmont Heights? If not, you can watch it <a href="here">here</a>. All three of these candidates also answered questions about crime, city services, the tree ordinance, zoning, liquor licenses, the Cheshire Bridge bridge repair and more.

- 2. Morningside Elementary may change get schooled! APS has recommended that all 4th /5th graders in the Midtown high cluster (including Hope Hill, Mary Lin, Morningside and SPARK) all be rezoned to the former Inman Middle School building in fall 2022. While APS says this will address capacity concerns and provide academic equity, that program would max out capacity by 2026 and the academic benefits are far from clear - as is the impact on the neighborhood if families feel a K-3 Morningside program is less appealing. The K-5 alternatives involved rezoning some families from Morningside, Springdale Park and Mary Lin to create a new elementary school for the cluster, which also has its pros and cons. We are asking all neighbors to complete a simple 1-minute survey here to test the neighborhood's opinion on this so we can weigh in because this affects all families – whether you have current/future students or not. Reach out to us if you would like to know more ways to get involved to express support or opposition. More information is on the APS website about the parent survey and the recent recommendation. There is another article below with additional information and details for a community follow up meeting that APS is hosting next week. Please also feel free to forward this newsletter to neighbors who are not members, especially those with future students at Morningside Elementary.
- **3. SRO @ NPU-F.** The turnout at last month's NPU meeting to oppose the alcohol license for Octopus Kitchen + Bar was unprecedented with 500+ neighbors in attendance. The final vote to deny the application was 429-4. Now the decision lies with the License Review Board (LRB), and you can check the <u>LRB website</u> to see if they will be on the next meeting's agenda. As of right now, they are not listed for the October 19 meeting. There are NO ASSURANCES the LRB will follow the vote of the NPU during their review. If they grant the license, we will be following up with a communications plan to Mayor Bottoms since she could still deny the license if granted. Regardless we sent a great signal that we are watching for misleading applicants and are not going to accept them quietly.

It has been great to see so many people at the Sunken Garden Park concerts – come by tonight – and come early now that it is getting darker well before 8:00pm!

Don't forget – we have our annual meeting in November to approve by-law changes and the 2022 board slate. PLEASE GET INVOLVED. Help out now – <u>ask me how!</u> And if all this wasn't enough, don't forget to vote on or before November 2.



Preliminary Plans for Roundabout at E Rock Springs, Cumberland Road, and Beech Valley





## Update on Roundabout at E Rock Springs, Cumberland and Beech Valley

As many of you know, the Master Plan Implementation Committee of the Morningside Lenox Park Association (MLPA) has made great progress for the neighborhood. In May, we received preliminary plans from Dekalb County for the construction of a roundabout at the intersection of E Rock Springs, Beech Valley, and Cumberland Road (see figure above). The roundabout is part of a group of projects designed to make improvements along N Decatur Road.

This roundabout has broad community support and was a recommendation in the Morningside Master Plan approved in 2018. In January 2020, we did a survey of residents on the streets nearby the intersection to ask about the roundabout. We heard from 34 persons, including 30 who were in favor of the roundabout and 4 who had objections or alternative suggestions. We are also aware of multiple efforts in the past by residents along E Rock Springs and in Edmund Park to make this happen.

In June, we forwarded questions and comments from nearby neighbors to Jeff Rader, DeKalb County Commissioner, and David Pelton, Transportation Division. Specifically, we made three recommendations: 1) connect the existing sidewalks in the City of Atlanta to new sidewalks planned for the roundabout; 2) use construction materials that are permeable because significant amounts of water always deluge the intersection during and after storms; and 3) establish infiltration landscaping, again to address the water issues.

Last week, we heard back from the County. First, the County is proceeding with bidding improvements on North Decatur Road, including mini-roundabouts at the Springdale and Oakdale Road intersections. Second, the E Rock Springs roundabout requires additional drainage design, which is underway, and the project is likely to go out for bids in the first quarter of 2022.

#### Timeline:

- Fall 2018: The Atlanta City Council approved the Master Plan for Morningside.
- Spring-Summer 2019: MLPA Master Plan Implementation Committee reviewed plan, determined process for choosing first projects. The roundabout was one of the 5 selected projects.
- November 2019: Committee met with neighbors to discuss the projects selected.
  Committee wrote letters to our State Senator and Representative to tell them about the
  project and request guidance about working across two jurisdictions on road projects. The
  intersection is in the County of Dekalb; the City of Atlanta line is 1-2 houses in any
  direction from the center of the intersection.
- August 2020: Committee received email from State Senator Elena Parent about funding from the Georgia Department of Transportation to Dekalb County for the roundabout. "The Department will commit up to \$400,000 or 70% of the project cost, whichever is less."
- April 2021: Dekalb County Commissioners approved funding for improvements along N Decatur Road, including the roundabout.
- May 2021: Committee received preliminary plans for the roundabout.
- June 2021: Neighbors requested that the roundabout plans include details about drainage, landscaping, and connecting existing City and County sidewalks.
- September 2021: County indicated that additional drainage design work was underway and that project would likely be bid out in early 2022.





## **Vote on New Zoning Proposals**

At the NPU-F meeting this upcoming Monday (October 18), there will be a vote on the Department of City Planning's new zoning proposals. The proposed ordinance includes allowing accessory dwelling units (also known as ADUs), smaller apartment buildings, and more density around MARTA stations in residential neighborhoods. Here is the <u>amended fact sheet</u>.

The Office of Housing and Community Development has shared three versions of Z-21-74: one clean, one redline of the original ordinance, and one redline of the changes from the September to October version. The main changes since last month are updates to lot coverage and unit size allowances in MR-MU. They also made some minor edits to add clarity and consistency throughout, including some tweaks to the sections pertaining to for-sale accessory dwellings. The Office of Housing and Community Development team will be attending next week's NPU-F meeting to present on the ordinance and changes that have been made as a result of NPU and neighborhood feedback.

This item will be heard by the Zoning Review Board on November 4, 2021, after going through all the NPUs. Several NPUs - including A, D and E - have voted in opposition. 

## **Get Schooled on Changes at Morningside Elementary School**

Because this is such a major change that will impact many of our residents, we want to reiterate what was mentioned above in the President's note. You don't know what you don't know ...

Atlanta Public Schools (APS) recently announced a recommendation to make the former Inman middle school building a 4<sup>th</sup>/5<sup>th</sup> academy for all elementary schools in the Midtown High School cluster (Hope Hill, Mary Lin, Morningside and Springdale-Park). This would make the current Morningside Elementary School a K-3 program and move all rising and future 4<sup>th</sup>/5<sup>th</sup> graders to the Inman academy in August 2022.

While we are aware of many parents concerned about the resulting lack of walkability, the proven benefits of a K-5 program and the number of transitions students have had in recent years, the MLPA wants to represent the entire neighborhood's feeling about such a big change to this centerpiece of the community before APS finalizes a vote on this topic in December. APS promotes the potential academic benefits of this proposed program and the relief of future overcrowding, but there is no other such academy in the system and there are unknown impacts on long-term desirability of homes for new families without a six-year elementary program. The other option under consideration was the creation of a new K-5 elementary school for the cluster and involved rezoning some families from Morningside, Springdale Park and Mary Lin (which also has its pros and cons).

We would appreciate you taking one minute to fill out this survey by October 20.

## **Zoning**

There will be another zoning-related vote at Monday's NPU-F meeting. The Zoning Review Board (ZRB) is scheduled to hold a public hearing on November 4 or November 18, 2021 on amended legislation (that also prohibits ADUs from being short term rentals).

• Z-21-85 An Ordinance by Zoning Committee to amend the 1982 Atlanta Zoning Ordinance, as amended, by creating a definition of a "Short-Term Rental" and to allow a short-term rental as a use in certain zoning districts; and for other purposes

#### Fall is for Planting

October will be a busy month in Herbert Taylor Park & Daniel Johnson Park (HTDJ) as we embark on an ambitious habitat restoration project. The work is being done by volunteers with the generous financial support of the City of Atlanta and NPU-F. The Friends of HTDJ have conducted workdays over the past several years to remove a wide variety of invasive species that have crowded out our native flora. This grant will allow us to begin reintroducing native species in the understory that will nurture both native and migrating wildlife.

Many hands will make the work easier and it's a great opportunity for green thumbs and those that would like to be to come out and learn! We started the installation along the Taylor Trail from the kiosk at 1343 Pasadena Avenue to the Rock Creek Trail during our regular workday on Saturday, Oct. 9. Thanks to all the 20 volunteers who came and helped out—we will be back working again on Monday, Oct. 18 and Saturday, Oct. 23 from 9-11:00 AM so come spend some fruitful time in our park.

Don't forget to mark your calendars for the Fall Archeology Tour on Saturday, Oct. 30 at 9:00 AM. Meet at the kiosk with John Mayes, Friends of HTDJ Treasurer & amateur archeologist, for a tour and to see some of the pottery and projectile points he has found along the creeks in the parks. This will be a great outing for kids of all ages, and a chance to learn more about this state designated archeological site within our parks. HTDJ park was home to several ancient American cultures who left us clear evidence of their way of living.

**Beltline Northeast Trail Gravel Refresh and Trail Closures.** The unpaved Northeast Trail is getting a gravel refresh. Work should be complete by the end of October, barring any unforeseen circumstances. Work will be starting at the Clear Creek Bridge and the contractor will work their way down to Monroe Drive. This project will require some trail closures while the contractor is installing and compacting the gravel.
